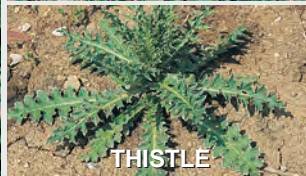
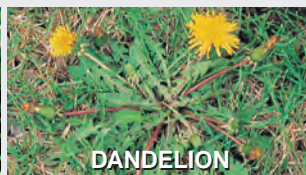
Trimec 992 is labeled for use on warm- and cool-season grasses
